I assume all of the foregoing risks and any other risks inherent in equine activities and accept complete responsibility for making any and all examinations or inspections. I further assume all risk of, and agree to hold harmless, the Warrenton Horse Show Association, The Warrenton Horse Show, and the Warrenton Horse Show grounds, their directors, managers, employees, representatives, and agents, from any and all loss, damage, injury or death to person or property, by whatever cause, including any act or omission, negligent or otherwise, on the part of the Warrenton Horse Show Association.
